LUMA is writing to inform P3A that PREPA responded to LUMA's September 26, 2024, letter regarding Shared Services Extension. While LUMA appreciates that PREPA accepted LUMA's February 28, 2025, extension date, PREPA revised other terms and conditions.

LUMA is attaching the only proposed extension it is willing to sign. LUMA has, in good faith, provided PREPA with a reasonable period of time to assume responsibility over functions currently provided by LUMA as Shared Services. LUMA has more than accommodated the additional requests made during this process.

LUMA is now asking P3A, as a party to the Amended and Restated Shared Services Agreement ("PREPA A&R SSA")¹ and as Administrator of the Puerto Rico Transmission and Distribution Operation and Maintenance Agreement ("T&D OMA")², to step in and require PREPA to sign the Shared Services extension agreement, as attached.
