RE: LUMA's letter to PREPA related to the Outage Event Account Reconciliation

Dear Executive Director Zapata:

As previously communicated by LUMA,¹ February is the fourteenth (14th) consecutive month on which the Outage Event Reserve Account has not been funded to the minimum balance amount of \$30 million established in the Puerto Rico Transmission and Distribution System Operation and Maintenance Agreement² ("T&D OMA"). As of February 2025, the Outage Event Reserve Account reflects a balance of \$1,639,117.00.

Additionally, the cumulative underfunding of the Outage Event Reserve Account is \$209,644,779. In other words, there are over \$200 million in expenditures incurred by LUMA in connection with responding to Outage Events during Fiscal Years 2022 through January 2025, including Tropical Storm Ernesto, which were paid from LUMA's Operating Account and have not been replenished by PREPA pursuant to the T&D OMA. Together, the unreplenished Outage Event costs and the missing minimum balance requirement, the funding requirement associated to the Outage Event Reserve Account is \$238,005,662.

LUMA is highly concerned that the Outage Event Reserve Account has not been replenished by PREPA, as required under the T&D OMA and the risk such underfunding represents to service restoration efforts following a future Outage Event, particularly during the upcoming hurricane season. LUMA requests that PREPA promptly replenish all Outage Event costs and maintain the required minimum balance in the Outage Event Reserve Account.

Nothing contained in this notice shall constitute a waiver or relinquishment by LUMA of any rights and remedies provided by the T&D OMA, the PGHOA³, and Applicable Law. LUMA reserves all rights and remedies under the T&D OMA, the PGHOA, Applicable Law and equity, including but not
